- 5. 21st Century School Fund*



Definitions

The following categories describe the entities with programmatic control over the site:

- **DC Public Schools (DCPS)** The site is either in use by DCPS or will be used for a future DCPS program based on their operational needs.
- **Department of General Services (DGS)** The facility underwent the Request for Offers (RFO) process, no award was made, and the site is awaiting determination for future use.
- **Deputy Mayor for Education (DME)** The RFO process is active and/or underway; the RFO process applies to former DCPS buildings that have been "excessed".
- Public Charter School (PCS) A public charter school owns or leases a former DCPS building.
- **Deputy Mayor for Planning and Economic Development (DMPED)** The facility underwent the RFO process, no award was made, and the building has been identified for a development purpose.
- University of the District of Columbia (UDC) Building awarded to UDC for exclusive use through Council legislation.
- Other District Agency The site is in use by a District government agency other than DCPS.

When DCPS Facilities Closed

Most of the DCPS facility closures (82%) occurred in 2008 or earlier.



Where DCPS Facilities Closed


A total of 110 buildings have closed to date. Almost half of the formerly closed DCPS buildings are located in Ward 5 and Ward 6.





Agencies' Use of Formerly Closed **DCPS Facilities***

Complete information is currently available for 85 of the 110 facilities. As of July 2017, 40 of the 85 formerly closed DCPS buildings are in use by public charter schools.



^{*} Subsequent slides exclude 25 formerly closed DCPS facilities. Twenty-four facilities that closed prior to 2000 are excluded due to incomplete information. Some of these are in use by other DC agencies or have been sold to the commercial sector. One facility (R.H. Terrell) has been razed and its land is in use by Walker Jones EC and DC Public Library.



Agencies' Use of Formerly Closed DCPS Facilities – Square Footage

As of July 2017, most of the square footage (in thousands of square feet) of the 85 formerly closed DCPS buildings are in use by public charter schools.





Section 2

How is DCPS Using 28 Formerly Closed DCPS Facilities?



- DCPS has 112¹ active facilities that support 48,555 students from PK3 through STAY programs for young adults².
- Since the 1940's, DCPS has closed 52% of previously existing school buildings (110 out of 211).
- Of the 28 closed facilities that remain in the DCPS portfolio as of July 2017:
 - 14 have reopened as new DCPS programs;
 - 3 are used as DCPS swing space;
 - 2 are used for DCPS administrative purposes;
 - 2 are significantly underused; and,
 - o 7 are vacant.



 - 1 school is in 2 formerly closed DCPS facilities
 - Duke Ellington School of the Arts is swinging in Meyer and Garnett-Patterson
 - 1 school is in another formerly closed facility
 - Bancroft is swinging in Sharpe Health
 - 2 are swinging in currently operating DCPS facilities
 - Marie Reed ES is swinging in MacFarland MS
 - Watkins ES is swinging in Eliot-Hine MS

14 facilities have reopened

- 1 school is in 2 facilities
 - Dorothy Heights is operating out of Burdick and Sharpe Health Annex
- 2 have reopened as part of an existing school and are considered part of the existing facility
 - Addison reopened as part of Hyde-Addison ES
 - Reno, Rose School reopened as part of Deal MS
- 3 are being used as swing space
